

# 57th Arts & Crafts Exhibition 2025

Cape Cornwall School, St. Just, TR19 7JX

**Exhibition dates:** Monday 4th to Friday 15th August.

**Opening times:** 10am - 7pm daily  
close at 5pm on final day (15th August)

**We welcome you to join us in our 57th Exhibition. If you wish to exhibit then please read these Terms and Conditions carefully. Last year, exhibitors who didn't comply were recalled to relabel or remove stock.**

## Conditions of entry

### **1: All exhibits must be entirely your own work.**

No kits, stick-ons, bought trims, peel-offs, decoupage, imprinted, stamped or downloaded work. Quality or commercial prints of your own original work are acceptable, but should be labelled as such. No plants or flowers are acceptable as part of a display. No artificial flowers, purchased toys, books, hairslides, lampshades, foodstuffs or drinks are acceptable.

All exhibits, hangers, display cabinets and shelves, etc are left at the exhibitor's risk, but we shall endeavour to keep your work safe and secure during the exhibition.

### **2: Commission.**

28% of the sale price of all sold items will be taken as a donation. 26% to Cancer Research UK and 2% to the Cape Cornwall School for hosting us. Please take that into account when you price your items. Orders taken at the exhibition for any item will also be subject to our commission fee.

### **3: For those entering Arts&Crafts.**

Whilst the organisers will try to ensure the safety and security of all items during the exhibition, items are left at the exhibitor's own risk.

**3.1:** Each item must be **clearly labelled** with your name (**personal name, not trade name**), exhibitor number in **GREEN** and price. Pricing should always be to the nearest 50p, (so £1, £1.50, £2, £2.50 and so on). Do not have any other numbers on the label as this may result in the sale being mis-recorded. Unlabelled items will be deemed to be donations for CRUK & will be sold to raise funds.

**3.2:** No reduced, sale items or 'seconds' are acceptable and prices cannot be reduced during the exhibition. There will not be any quantity discount offered.

**3.3:** Greetings cards and unframed mounted pictures are acceptable but should be supplied in tabletop display stands.

**3.4:** Display tables will be already dressed using CRUK colours, if you wish to use your own cloths then only pink, blue or white are acceptable.

**3.5:** Display tables are charged at the rate of £3 per foot, backboards (available for 4ft & 6ft tables) are additionally charged at £5.

**3.6:** It is the exhibitor's responsibility to ensure that all work complies with Government Safety Standards. The organisers do not accept any responsibility for those that do not.

**3.7:** Delicate and fragile items should be supplied with appropriate packaging.

### **4: Gold, silver and other items of high value.**

All gold and silver items must be hallmarked in accordance with the Assay Regulations.

**4.1:** All items of value must be supplied in a lockable perspex cabinet suitable for occupying a 3-foot table space. Please do ensure that you retain a spare key.

**4.2:** Jewellery items should be supplied with packaging, e.g. small boxes, trinket bags etc.

### **5: For those entering hung pictures.**

Firstly, we cannot accept work that is not for sale (NFS). We also reserve the right to refuse entries felt to be deliberately overpriced as to

inhibit any sale. We will also refuse any entry that is unsuitable for public display (including content and/or quality of finish). Having got that said and out of the way, we welcome all forms of framed or canvas art.

**5.1:** Commission will be 28% of the sale price as outlined above.

**5.2:** Up to 4 pictures can be entered and will be charged at £2.50 per picture entered.

**5.3:** Pictures can be original painted, drawn or mixed media artwork, or can be signed, limited edition, quality prints or archival photographs. But the work within the picture must be your own.

**5.4:** The hanging eyes should be screwed in a third the way down the frame and a taut wire or cord tied between them. Please use a good standard of mount, frame and backing.

**5.5:** We will supply 4 tie-on labels to all registered artists. Each picture must have both halves of one of these labels filled in with your name, artwork title, its medium, and your selling price.

**5.6:** The label needs to be tied onto the back with sufficient string that the label will hang over the top of the picture, (this is for our cataloging purpose).

**5.7:** The form needs to be completed and brought in with the pictures, SAE and hanging fee when you deliver. Pictures can be delivered at ANY time 10am - 2pm on Take-in days, see also 6.1 below.

**5.8:** We shall endeavour to hang at least 2 of each artist's pictures, depending upon size and space. Please number, 1 and 2, the two preferred pictures to be hung first.

**5.9:** When space becomes available 'reserve' pictures will be hung.

**6: Delivery. Craft-table exhibitors will be given a 2-hour delivery slot, please keep to that time.**

**6.1:** When you arrive please bring and hand in your completed and signed entry form, your Stamped Addressed Envelope (SAE) and your entry fee. (Without that SAE we cannot send you your sales cheque).

**6.2:** We will not be checking in your arts and crafts; you will be directed to your display space only, **however before the show opens your work will be checked.**

**6.3:** During the exhibition, you can restock as required, but please ensure all new items still meet the conditions as set out above and supply us with a list of additional stock. Spare stock can be kept under

your table. We will endeavour to check for spare stock and re-fill your table space as required.

**6.4:** We advise you to keep your own record of submitted work as entry forms will not be available or returned.

**7: Collection: All items must be collected between 10am - 1pm on Saturday 16th August.**

**7.1:** Note that you can only collect your work within that 3-hour window.

**7.2: If you cannot collect then, please do not enter your work in the first place.**

**7.3:** There will be **no early collections or removal of exhibits.**

**7.4:** We will not be checking out your items.

**7.5:** Any items left after 1pm on 16th August will be deemed as donations to the CRUK.

**7.6:** Cheques will be posted in your SAE. Without that SAE we cannot send you your sales money. **Do ensure that we have your correct name for your Bank Account.**

Finally, we hope that you have a successful exhibition. Please publicise as much as you can, please display posters, and spread by word of mouth and social media, etc. We shall endeavour to do the same, it is in all our interest to sell as much as we can during the exhibition, raising money for Cancer Research.
